Amateur Radio License Examination Session Instructions

- 1. The Sterling Park Amateur Radio Club (SPARC) and the Dulles Amateur Radio Group (DARG) will jointly conduct a Volunteer Examination Session on **Sunday, 1 October 2023**. The location will be the Eastern Loudoun Station of the Loudoun County, Virginia Sheriff's Office at 46620 East Frederick Dr., Sterling, VA 20164.
- a. The examination session will be conducted under the auspices of the ARRL/VEC, in accordance with their processes and procedures.
- b. The examination is by appointment only. There will be no walk-ins. You apply for an appointment by emailing Gordon, NQ4K, at gormil@aol.com.
- c. Two sessions are planned: one at 1 pm (primarily for members of a SPARC sponsored tech license prep class) and a second at 2:00 PM (for all others). On the Monday or Tuesday prior to the exam, you will receive E-mail with more details and the time you need to be at the test location on that Sunday.
 - d. Examinations will be offered for Technician, General, and Amateur Extra classes.
- 2. **Fees:** There are **two** fees associated with taking the examination.
- a. There is a \$15 fee for taking an exam at the VE examination session, cash (exact change required) or check (made payable to ARRL/VEC).
- b. There is a \$35 application fee (for a new, renewal, rule waiver and modification application) payable directly to the FCC. After the examination, you will receive an email explaining how to pay this fee. See http://www.arrl.org/fcc-application-fee for further information on how to pay this fee. This is paid directly to the FCC and not to ARRL or the examination team.

ON EXAM DAY, EXAMINEES SHOULD BRING THE FOLLOWING ITEMS:

- 1. Identification
 - a. A legal photo ID (driver's license, passport, military ID).
 - b. When no photo ID is available, two forms of identification must be presented:
 - 1) Non-photo ID/driver's license (some states still have them)
 - 2) Birth certificate (must have the appropriate seal)
 - 3) Social security card
 - 4) Library card
- 5) Utility bill, bank statement or other business correspondence that specifically names the person; or a postmarked envelope addressed to the person at his or her current mailing address as it appears on the Form 605.
- c. Students may bring any of the above items and/or a school ID, minor's work permit, report card, or a legal guardian may present a photo ID.

- 2. You \$15 examination fee. See above.
- 3. Your FCC issued Federal Registration Number (FRN).
- a. You must use your FCC issued FRN. The FCC requires you submit your FRN number with your license application form.
- b. For instructions on how to register your SSN with the FCC and receive a FRN, visit the FCC's FAQ page (https://fjallfoss.fcc.gov/coresWeb/faq.jsp).
- 4. If applicable, bring the original and a photocopy of your current Amateur Radio license and any Certificates of Successful Completion of Examination (CSCE) you may hold from previous exam sessions. The photocopy(s) will not be returned. VERY IMPORTANT if currently licensed.
- 5. A completed (in ink) NCVEC 605 form. You must use the NCVEC 605 form (NCVEC Quick Form for Application Amateur Operator/Primary Station License), NOT the three-page FCC 605 form that is found on the FCC website. The form may be found at: http://www.arrl.org/fcc-forms or http://www.ncvec.org/downloads/NCVEC_Form_605_2022.pdf.
 - a. SPARC will provide a NCVEC 605 form to members of the SPARC Tech License Prep class.
 - b. Others may download the form may also be downloaded from http://www.arrl.org/fcc-forms
- 6. Two number two pencils with erasers and a pen.
- 7. A calculator with the memory erased and formulas cleared is allowed. You may not bring any written notes or calculations into the exam session. Slide rules and logarithmic tables are acceptable, as long as they're free of notes and formulas. Cell phone must be silenced or turned off during the exam session. The phones' calculator function may not be used.
